ARTICLES OF INCORPORATION
OF

STORM MOUNTAIN EMERGENCY RESPONSE TEAM, INC.

KNOW ALL MEN BY THESE PRESENTS THAT the undersigned person, acting as incorporator of this Corporation under the Colorado Nonprofit Corporation Act, signs and acknowledges the following Articles of Incorporation for such Corporation.

ARTICLE ONE: The name of the corporation shall be STORM MOUNTAIN EMERGENCY RESPONSE TEAM, INC., a Colorado Nonprofit Corporation.

ARTICLE TWO: This Corporation shall have perpetual existence.

ARTICLE THREE: The purpose for which this Corporation is organized is to serve as the Association for the STORM MOUNTAIN EMERGENCY RESPONSE TEAM in Larimer County, Colorado. The Corporation may conduct any lawful activity pursuant to the Colorado Nonprofit Corporation Act in fulfilling such purpose.

ARTICLE FOUR: In addition to all other powers lawfully enjoyed by it, this Corporation shall have all powers granted by the Colorado Non-profit Corporation Act.

ARTICLE FIVE: Upon dissolution of this Corporation, its assets shall be applied and distributed in accordance with Article 134 of Title 7, C.R.S.

ARTICLE SIX: This corporation shall indemnify its directors, officers, employees, and agents to the fullest extent allowed by Colorado law, as authorized by Article 109 of Title 7, C.R.S. The directors, officers, and members of this Corporation shall have the benefit of the limitations on personal liability for any injury to person or property arising out of a tort as set forth in 7-108-402, C.R.S.

ARTICLE SEVEN: The membership of this Corporation shall at all times consist exclusively of all members of the STORM MOUNTAIN EMERGENCY RESPONSE TEAM. **The members have voting rights.**

ARTICLE EIGHT: The address of the initial registered office of the Corporation is 2278 Spruce Mountain Drive, P.O. Box 390, Drake, Colorado 80515. The name of its initial registered agent is Roger Debenham.
